

Terms and Conditions of Use

Please read this User Agreement before using this website.

Welcome to the myPPMI Participant Portal (referred to as the “portal” throughout this document), where you can access your journey through various phases of The Parkinson’s Precision Medicine Initiative (“PPMI”) Study. This is a landmark observational clinical study that aims to improve the understanding, management, and treatment of Parkinson’s disease (PD) that is sponsored by The Michael J. Fox Foundation for Parkinson’s Research (“MJFF”).

PPMI is not a health care provider and is no substitute for treatment by a physician or other health care provider.

PPMI depends on its users to input accurate and truthful information and does not independently verify it unless the PPMI administrator is specifically notified about a potential problem. You hereby agree to input accurate and truthful information when you participate in the Study and verify it with us if we contact you.

may not take any action that imposes an unreasonable burden upon the infrastructure used to support the efficient operation of this website.
